The precept request was signed by the chair after the meeting. **RESOLVED:** Members agreed the precept increase of 5% to £18,026. 23 / 45.00 POST OFFICE CLOSURE UPDATE Cllr Nelson and Evans updated members regarding the Post Office (PO) closure:

A great many letters have been sent and a petition. Responses from the PO have been poor and not acknowledging or responding to the specific points raised by the PC or other local residents. A freedom of Information request had been sent back redacted. We will continue with our campaign. A meeting with the MP has been requested.

- **23 / 48.01** D Cllr Clarke and D Cllr Ellis Brown updated members regarding HDC items:
 - The Local Plan is now out for consultation.
 - Local elections are changing, regarding who can vote
 - There are a number of local environment grants available: details on the HDC website
- **23 / 48.02** Cllr Dreger informed the council that cycling routes were planned for Petersfield to Midhurst using the old railway line: which might be a model for the development of the Pulborough to Midhurst old line.
- **23 / 48.03** Cllr Lane asked about the footpath and pavement restoration needed along the A29: no update at this point.
- **23 / 48.04** Cllr Evans reported the event at The Labouring Man in December had raised £1100, 170kilos of food and 10 large bags of toys for Horsham Matters
- 23 / 48.05 There was some discussion of Church Hill in Pulborough: the issue is now in the Crown Court.
- 23 / 48.06 Clir Nelson reported to the council the very sad news that former member of the PC **Mrs Pauline Streeter** had died last week. Mrs Streeter was a very special member of our community, who not only was known to all through her role as our local post-mistress but worked tirelessly to support many local residents in a wide number of ways, such as the village help scheme. She will be greatly missed.
