Application For: Erection of an Eco camping lodge.

Cllr Lane presented the plans to the meeting.

Members had reservations that the proposed building is substantial and out of proportion for the area, they raised concerns about the size and scale of the building and that the style of the roof is imposing, refer to SD40 the proposed building isn't broadly compatible nor relate to the landscape. The plans only show 3 parking spaces which they felt was too few for a four-bedroom lodge.

Members also observed that the building appears to be position on the old railway line, which raises questions regarding access for other users along the track.

Members asked that the water neutrality should be examined closely as the building includes 4 baths and showers along with the kitchen facilities, with potentially a minimum of 8 persons staying potentially all week.

RESOLVED: Members resolved to object to the application as above.

The clerk advised that the recent application at Coldwaltham House (SDNP/23/01773/FUL) had been amended to "Erection of a stable building and associated landscaping." Removing all mention to demolish the part of the stable block.
