

- ¹ Disclosable Pecuniary Interest' is defined in SI 2012/1464 and includes matters set out in questions A and C to G inclusive of this schedule.
- " "Your partner" means (a) your spouse or civil partner; (b) a person with whom you are living as husband or wife; (c) with whom you are living as if you were civil partners.
- "12 months" means the period of 12 months ending with the day on which you give a notification for the purposes of the Localism Act 2011 sections 30(1) or 31(7).
- "Body" means a firm in which either of you is a partner or a body corporate of which either of you is a director or in the securities of which either of you has a beneficial interest. "Director" includes a member of the committee of management of an industrial and provident society.
- ^v "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income.
- vi "Securities" means shares, debenture stock, loan stock, bond units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
- vii "Sensitive Information" means information whose availability for inspection by the public could lead to you or a person connected with you being subject to violence or intimidation.
